IN DECEMBER 2022, THE JACQUELINE AVANT CHILDREN AND FAMILY CENTER OPENED ITS DOORS AND THE MLK PEDIATRIC CLINIC MOVED INTO 20,000 SQ. FT. ON THE FIRST FLOOR OF THE THREE-STORY 50,000 SQ. FT. BUILDING. THE CLINIC SERVES 4,000 CHILDREN AND TEENS ANNUALLY BY PROVIDING MEDICAL AND MENTAL HEALTH EVALUATIONS FOR THOSE WHO HAVE BEEN EXPOSED TO VIOLENCE, AND PRIMARY PEDIATRIC CARE FOR CHILDREN IN THE COUNTY'S FOSTER CARE SYSTEM. THE FIRST OF ITS KIND CENTER WILL PROVIDE ENHANCED OUTPATIENT CLINICAL SERVICES FOR AT RISK PEDIATRIC AND ADOLESCENT PATIENTS AND THEIR FAMILIES IN SOUTH LOS ANGELES. THE CLINIC HAD BEEN HOUSED FOR MORE THAN 40 YEARS IN DILAPIDATED CONSTRUCTION TRAILERS THAT HAVE BEEN DEMOLISHED AND WILL ALLOW FOR A NEW PARKING LOT FOR THE CLINIC. MLK-CDC PLANS TO CONSTRUCT A CHILDREN'S (CONT SCH O)

INFLUENZA VACCINES, HIV TESTING AND PRE-EXPOSURE PROPHYLAXIS EDUCATION AND SUPPORT IS PROVIDED. THE MLK-OPC ADMINISTERED OVER 22,000 COVID-19 VACCINES, 13,000 WOMEN'S HEALTH-SPECIFIC VISITS INCLUDING BREAST CANCER SCREENINGS. DREW UNIVERSITY OF MEDICINE AND SCIENCE ("CDU") LOCATED ON THE MLK MEDICAL CAMPUS TO EXPAND ITS UNDERGRADUATE PROGRAM AND IMPROVE ITS ADMINISTRATIVE AND TEACHING FACILITIES. THE MLK-CDC HAS PROVIDED GUIDANCE ON REDEVELOPMENT OPPORTUNITIES THAT WILL INCLUDE BIO-MED LABS, UNDERGRADUATE STUDENT AND FACULTY HOUSING. IT INTRODUCED CDU TO FUNDING SOURCES FOR DEVELOPMENT OF A MASTER PLAN AND FACILITATED PARTNERSHIPS BETWEEN CDU AND EXISTING HEALTH CARE ENTITIES INCLUDING THE MLK PEDIATRIC CLINIC.
